Pastor's Reflection

Easter Miracles Come True!

I believe in Easter Miracles! However, they can be just a little like giving birth. I say that because the kind of miracle I am talking about is the miracle of healing relationships. If you have fallen out with someone it is likely you have something to clean up and to possibly even apologize for. I seem to always have some apologizing to do. I have taken stock in my relationships and started making a few calls in hopes to restore what had been lost. It is likely I will need to hear about something I did or did not do, take responsibility, and authentically apologize. It was about this time last year when I reached out to someone that I had been holding a grudge against for many years. I know, shocking a pastor could hold onto a grudge for years. It was easy, I was right and he was wrong! So, I told myself.

I made the mistake of bringing up this grudge I had been holding on to for some 16 years at one of the adult bible studies and they highly encouraged me to call the person and work it out. Reluctantly I took their advice and made the call. The call was awkward to say the least, but the result was fantastic! We both had a few things to apologize for, and by the end of the conversation our relationship was restored. Having warmth in my heart for him and not that thorn of the grudge made such a difference in my daily walk. I encourage all of us to take stock of our relationships. Where has a coolness set in where there was once warmth? We are all about deepening of faith this year and nothing does more to deepen our faith than restoring our relationships.

You might challenge these thoughts as simplistic and overly sentimental notions that do not stand up to the real problems, such as standing up for one's principles. We as Christians get that. After all, Christ was hung on a cross for standing up for his principles, but we also understand and following Christ's example, to never stop forgiving, loving, caring, reaching out to others. In a world that is so polarized by principles one must be cautious, understanding that we are not infallible, even in our principles. Another challenge might be for those that keep forgiving to only be hurt again. Please do set good boundaries for healthy relationships and do keep yourself safe. We are called to love and forgive, but we are not called to allow ourselves to be taken advantage of or hurt. These can be very hard issues to resolve by yourself, so please do not hesitate to call for help. Now with all that said, time and time again Jesus challenges us to reconcile our relationships.

We have such a great Lord and Savior. He made it clear what it takes to follow Him from brokenness to being one with God. He said love your enemies. He said may the first one without sin throw the first stone. He taught us what it means to be the good neighbor. He taught us just how far He would go to love and forgive us as He proclaimed from the cross, "Lord, forgive them for they know not what they do". In just a few short days we will celebrate the glorious truth that the light of Christ was not put out; that He walked out of that tomb and is still walking with us today! He meets us along the way as we follow Him, caring, loving, forgiving. Yes, He lives! Deepen your faith and live the Easter Miracle by doing the work. Make that call to that friend or relative that has drifted away, send that letter to the one that broke your heart, soften your heart to the one that has hurt you, trade being right about that argument for the relationship that once was. Get started, the result may not be a healed relationship but you will be living the Gospel of Christ and that is always a good thing!

REVIEW/APPROVE MINUTES FROM THE JANUARY 9, 2023 COUNCIL MEETING, JANUARY 29, 2023 ANNUAL CONGREGATIONAL MEETING, & ORGANIZATIONAL COUNCIL MEETING

The minutes from the January 9, 2023 Council meeting, the minutes from the January 29, 2023 annual meeting and the short council meeting for organization were reviewed. Correction was made to remove Andrew Watts from attendance record from January 9, 2023 council meeting. A motion made by Cheri Langsdorf, seconded by Susan Koesterer, to approve the minutes of the January 9, 2023 council meeting, January 29, 2023 annual meeting, and organizational council meeting. Motion carried.

REVIEW/APPROVE TREASURER'S REPORT/BILLS/TIMECARD/PASTOR'S EXPENSES

The treasurer's report/bills/timecard and Pastor's expenses were presented and reviewed. There were no additions or corrections. Sandy Tutka made a motion to approve the reports as presented and it was seconded by Andrew Watts. Motion carried.

PASTOR'S REPORT

Pastor reported he is happy with the way things are going with our church attendance but encouraged everyone the need to still keep working to get people to come to church regularly.

COUNCIL MEMBERS REPORTS

There were no reports from any council members.

OLD BUSINESS

We are still waiting on one piece of equipment to complete the sound system. Alobars is frustrated as well and will let Pastor know when the final piece comes in.

The adjusted fees for wedding rental were discussed. The deposit for non-members rental of the lower level of the fellowship hall was listed twice on the contract. The contract will be changed to read the deposit for the lower level (kitchen & dining hall) will be \$75.00 and the fee for the upper level will also be \$75.00. A motion was made by Amy Rohlfing and seconded by Faye Ross to accept the change as proposed. Motion carried.

Pastor gave the update on the parsonage which is coming along very nicely. Everything is moving along in the right direction. The new roof has been completed.

Cheri Langsdorf gave Lisa's report for Fastnacht. The online ticket sales are very slow. Lisa has done a great job of lining up workers, getting some of the younger members involved, noting the importance of keeping the tradition alive.

NEW BUSINESS

Glenn and Linda Coats have brought it to our attention that there are two buildings next to their property which they have been using for many years for storage. It is believed that these two buildings are actually on church property. Glenn and Linda have been using and maintaining the area around the buildings for

many years. Mark Rey is looking into the actual survey of the property to make sure they are indeed on church property. Glenn and Linda would like to continue using them as they have been. It was suggested that more information needs to be gathered concerning liability, insurance, etc. before a decision can be made.

<u>TREES</u>: There are several trees that need to be taken down in and around the pine forest. Andrew Watts will check to see if he can get a couple of people to help take down the trees. He will also contact Ameren regarding cutting down a couple of trees that are in close proximity to power lines.

SOLAR POWER:

Pastor gave a description of the proposed solar power panels and costs. A gentleman came to the men's club meeting and gave a description of where the panels might be placed, should we decide to go with solar power. The total estimated cost would be approximately \$90,000.00 The breakdown of payment is as follows: 1/3 coming from a tax credit; 1/3 coming from the utility company and the remaining 1/3 would be the responsibility of the church. This particular company has installed solar panels for several church members and comes highly recommended. Pastor will get more details and report back as information becomes available.

COPIER CONTRACT:

Cheri Langsdorf made a motion to accept the copier maintenance contract as presented and Amy Rohlfing seconded the motion. Motion carried.

MOWING:

An estimate for mowing the church property including the parsonage and fellowship hall on a weekly basis (unless it is a very dry week) was presented from Rehmer-Ruemker Lawncare, Columbia, IL. The fee of \$350.00 each time includes mowing, trimming, blowing, fuel and the use of their equipment. A motion was made by Faye Ross and seconded by Cheri Langsdorf to accept the bid for mowing as described. Motion carried. Pastor will contact the cemetery board and let them know the council approved the mowing contract and for them to get a fair market value appraisal for the existing mower and to go ahead and sell it. Proceeds are to be divided between the cemetery board and the church.

OFFERING ENVELOPES:

Pastor has "several" boxes of offering envelopes that have not been picked up. Some of the church council members offered to help deliver some of the envelopes. It was also discussed that if church envelopes are not picked up and used for 2+ years, that perhaps we should no longer go to the expense of having them printed.

A motion was made by Amy Rohlfing and seconded by Susan Koesterer to adjourn the meeting. The meeting was adjourned with Pastor leading us in the Lord's Prayer.


