Pastor's Reflection

The Tail Wagging the Dog

The tail wagging the dog is an old-time saying meaning we have lost sight of the big picture over an issue. The issue, although important, should not derail the mission or purpose. Politicians use wedge issues to stir up their base, media use wedge issues to draw in viewers. Nothing sells better than a good wedge issue. The problem becomes *the tail is wagging the dog*. Few issues are as simplistic as the sound bite. Let us look at the number one wedge issue for the past 40+ years. Pro Life vs Pro Choice.

This is clearly a serious and important issue, but can it be boiled down to a sound clip to push a wedge issue or is it better to treat it as the complex issue that it is? Here are some important facts that we never hear from our politicians to keep in mind.

“What is the abortion rate among women in the U.S.? How has it changed over time?

Guttmacher says that in 2020 there were **14.4 abortions in the U.S. per 1,000 women ages 15 to 44**. Its data shows that the rate of abortions among women has generally been declining in the U.S. **since 1981, when it reported there were 29.3 abortions per 1,000 women** in that age range.

The CDC says that in 2020, there were **11.2 abortions in the U.S. per 1,000 women ages 15 to 44**. (That figure excludes data from California, Maryland, New Hampshire and the District of Columbia.) Like Guttmacher's data, the CDC's figures also suggest a general decline in the abortion rate over time. **In 1980, when the CDC reported on all 50 states and D.C., it said there were 25 abortions per 1,000 women ages 15 to 44.”**

Prior to *Roe v. Wade* we have no clear numbers showing how many abortions occurred as it is hard to track what is done illegally. Here is some history dating back to our founding fathers via the Wikipedia.

Early history and rise of anti-abortion legislation

Abortion has existed in North America since the *European colonization of the Americas*,^[21] was a fairly common practice, and was not always illegal or controversial.^{[22][23]} Until the 19th century, abortion was legal under *common law*, and only after *quickening* it was not allowed.^[24] *Quickening* indicates the start of *fetal movements*, usually felt 14–26 weeks after conception, or between the fourth and sixth month.^{[22][25][26]} Its determination was generally at the discretion of the pregnant woman,^[27] but the rules were unstated or unclear in written statutes.^[28] When the United States became independent, most *U.S. states* continued to apply *English common law* to abortion.^[29] In the mid-1700s, Founding Father *Benjamin Franklin* amended a general textbook from Britain to include a manual with instructions for early pregnancy abortion methods.^{[30][31]}

You might take from this that Pastor is pro-choice. Please do not assume that. I am very much Pro-Life, just not in the political sense. All life is sacred, the bible affirms that throughout, again and again. But simplistic answers such as making

it illegal has proven to fail and only put women at great risk. We must stand outside the wedge issue argument that reduces the complexity to a one liner. Like many of you, where I stand on an issue as important as this is outside the political arena. We look at the long history, the professionals in the field, what is working and not working. Complex issues call for complex thinking and the solutions may take decades to realize gains. We know any real solutions will require care, compassion, listening, and they will need to take into consideration the health of the woman, mentally and physically. The solutions must provide for a safe place to receive affordable health care and unless we believe that abstinence only is viable, the solution must provide reliable contraception if we want to reduce unwanted pregnancies. However, the wedge issue is not truly looking for a solution. Its primary goal is to drive people to the polls or their news show. It is designed to keep us separated. Here is a poll they should take and we would likely all be on the same page.

“Are you in favor of reducing unwanted pregnancies? Yes, No.”

“Are you in favor of continually lowering the need for abortions? Yes, No.”

“Are you in favor of reducing the number of abortions? Yes, No.”

The answers to these questions would overwhelmingly be ‘yes’ regardless of their politics, but building consensus does not drive the voters to the polls. Neither party wants to speak about the issue in real terms. If politician made a statement such as,

“Abortions continue to decline moving from a high in 1981 of 25 per 1000 to 11 per 1000 pregnant women in 2020. We have made great progress, but it is still vital that we do more to meet the needs of our young women and men to protect them and the life of the unborn baby”

Politicians on both sides are smart. They know that such a message would not provide the drama to keep voters motivated to vote for them. The churches also get wrapped up in wedge issues and lose their ability to speak to the complexities. The Southern Baptist Church once took a much more nuanced approach to abortion. This is a quote from Good Faith Media.

In 1971, the Southern Baptist Convention passed the first of four resolutions that most would consider “pro-choice” today.

Messengers to the convention affirmed the sanctity of human life, including that of a fetus, but they also called upon Southern Baptists to protect a woman’s right to an abortion.

The resolution reads, “We call upon Southern Baptist to work for legislation that will allow the possibility of abortion under such conditions as rape, incest, clear evidence of fetal deformity, and carefully ascertained evidence of the likelihood of damage to the emotional, mental, and physical health of the mother.”

Messengers would reaffirm the 1971 statement in 1974, proclaiming that the 1971 resolution “reflected a middle ground between the extreme of abortion on demand and the opposite extreme of all abortion as murder” and “dealt responsibly from a Christian perspective with complexities of abortion problems in contemporary society.”

In 1976 and 1977, the SBC passed softer resolutions which argued “that in the best interest of our society, we reject any indiscriminate attitude toward abortion, as contrary to the biblical view ... and support the right of expectant mothers to the full range of medical services and personal counseling for the preservation of life and health.”

Prior to the late 1970’s, most SBC leaders viewed abortion as a deeply personal issue that was complex and not simply a “right to choice” versus a “right to life.”

The Southern Baptist Church today is adamantly opposed to their own position just a few decades earlier. Not to just pick on the Southern Baptist, we in the UCC have our own set of wedge issues we champion to the effect of losing sight. One last bit of history. The Roman Catholic Church has not always seen abortion as murder of a fetus. Here is quote from PubMed. [Title Abortion and the Catholic Thought](#). This article follows the stream of thinking.

Early Church leaders began the debate about when a fetus acquired a rational soul, and St. Augustine declared that abortion is not homicide but was a sin if it was intended to conceal fornication or adultery. During the period of 600-1500, illicit intercourse was deemed by the Irish Canons to be a greater sin than abortion, Church leaders considered a woman’s situation when judging abortion, and abortion was listed in

Church canons as homicide only when the fetus was formed. St. Thomas Aquinas declared that a fetus first has a vegetative soul, then an animal soul, and finally a rational soul when the body was developed.

Now that we have touched on the Faith Tradition in the Church. What does the bible have to say about when life begins.

Genesis 2:7

“then the LORD God formed man from the dust of the ground, and breathed into his nostrils the breath of life; and the man became a living being.”

Many quote Genesis as to say life begins at the baby’s first breath. Others will quote Jeremiah to make the argument it begins even before conception.

*Before I formed you in the womb I knew you, and before you were born I consecrated you. (Jeremiah 1:5)
My frame was not hidden from you,
when I was being made in secret, intricately woven in the depths of the earth.
(Psalm 139:15)*

Personally, I think both sides are taking the scriptures out of context to make an argument that the bible is not making. Simply put, the bible is not making a case for or against abortion. These scriptures do speak to the gift of life and to God’s profound depth of knowing and caring for us. How we apply that profound truth is ours to struggle with, hopefully taking into consideration the many complexities in answering how best to care for all of life. One can make a very sound argument in scripture that all life is sacred and that applies to a very wide set of issues from feeding and caring for the least of these to being good stewards of the creation. The argument that I am making is ultimately not even about abortions rights. That is just an example of a wedge issue and how they have the effect of *the tail wagging the dog*.

As people of faith, we must be bigger than the politics that separate us and reduce our ability to address complex issues. I am sad to say that politicians and organizations will weaponize faith to embolden their case and push the wedge issue agenda. Those with differing viewpoints get painted with a brush that they are unfaithful, not taking their bible seriously, “That a true Christian take their bible literally”. We must protest to that narrow viewpoint. It is our duty to read the bible and discern how to allow it to guide us in our time and context. When we take a few verses and use it to make a case we often miss represent the original intent of the scripture, and the consequences of that hurt people deeply. In the United Church of Christ, we believe following Christ requires us to think deeply about the scripture and how to bring the love of Christ into each and every issue. In the UCC, and certainly in our church, there is not just one opinion. There is not a company line to follow or you are out. We need all our members’ viewpoints as we strive to be our best for Christ as a church. I feel privileged to walk in faith with our members and their wide range of positions on most any topic. I hear in our members a desire to stand up for what is right and a desire to bring common sense and compassion to the issue.

The next wedge issue already sweeping our nation is over transgender issues. Notice the *tail already wagging the dog* as commonsense goes out the window. The narrative is being shaped on both sides to push the agenda. If there was ever a time for cool heads with the capacity to think deeply about an issue that will be with us for decades to come, it is now.

The next visitor article will speak to the issue. I will not be making a case for opposite genders to share bathrooms. I will not be making a case for children or their parents to make life long lasting decisions on the thoughts and feeling of an adolescent. I will be making the case to be compassionate and patient. I will address what the bible says and does not say about homosexuality as it will certainly be at the center of this issue. These are topics I will not preach from the pulpit as they lack the ability to unite us in the spirit. They are topics that I feel you would welcome a voice from your pastor. These are troubled times but there has never been a time without troubles. Let us greet these days with hearts full of love and grace, bringing the spirit of Christ into our world!

WAIVER OF ESTATE FINANCES

Pastor Poole and Mark Rey signed the Waiver of Trust Accountings for the Joyce Ann Sliment Revocable Trust. The same thing was done one year ago.

A motion was made by Cheri Langsdorf and seconded by Lisa Schwarze to adjourn the meeting. The meeting closed with Pastor leading us in the Lord's Prayer.

What kind of story does the Easter Bunny like best?



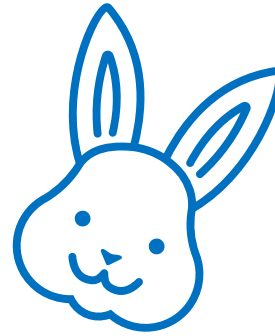
The ones with hop-py endings, of course!!
